### President's report



After the very successful national conference in Kiama in September 2022, the following year was conducted at a slower pace but still very successful. As in previous years we

held three gatherings and one weekend get-together during the year. The first was held in March hosted by Sutherland District Group and in May the Central Coast hosted a gathering which also incorporated the AGM. In September the Illawarra Group, which had only been formed in the previous year, hosted a gathering, and in November the Southern Tablelands Group hosted a very successful weekend gettogether in Goulburn.

Membership numbers are very healthy with 1,181 memberships and 1,479 members.

Our financial performance was considerably less than the previous year when we hosted the national conference. However it still produced a healthy profit and enabled us to continue to support scientific research into and awareness of native plants.

We have provided the secretariat for ANPSA, the national body to which all the state organisations subscribe, for the last year. It has not been particularly onerous, but we look forward to handing this over to Victoria at the national conference in Melbourne in September, and I look forward to as many of our members as possible attending this event. From the programme it looks very worthwhile.

District groups continue to function well and provide an extremely varied programme of activities. In 2023 the 19 district groups held a multitude of

activities comprising meetings with speakers on topical subjects, garden visits, bushwalks, plant propagation and nursery management, together with numerous types of conservation activities. Through the medium of the regular online newsletter groups can be informed of the activities of other groups and this provides a strong degree of cross fertilisation of ideas. In addition a number of district groups have formally arranged joint activities with adjoining groups.

In recognition of outstanding contributions over many years we welcomed two new life members, Jenny Simons and Tim Hayes. The annual conservation award was presented to Jane Lemann in recognition of a more than 30 year contribution to the protection and restoration of the Southern Highlands Mount Gibraltar.

There were a number of changes in the Board during the year. Peter Olde, Sue Fredrickson and Lisa Godden resigned from the Board and we thank them for their contributions. Rhett Morson from Newcastle group was appointed.

As a fully voluntary organisation with no employees and only a small number of specialist service providers we rely on a large number of our members contributing in various ways. A wide range of skills and expertise is required and I wish to thank all of our members and volunteers for their contributions during the year. Furthermore I would invite all members to consider how they may contribute.

# 2023 Life Memberships and Conservation Award

Congratulations to Jennifer Simons (Southern Highlands) and Tim Hayes (Southern Tablelands), who were made Life Members of APS NSW and to Jane Lemann (Southern Highlands), who was awarded the Society's Conservation Award.

Tim was founding member of Southern Tablelands Group and has been a stalwart of the Group ever since, holding many committee positions and writing the newsletter for many years. He has an extensive knowledge of the flora of the area and has produced plant lists for a number of specific areas. Tim's propagation skills have been invaluable in assisting a nursery, providing plants and advice at the Goulburn wetlands and providing large quantities of plants to Landcare. He is regarded as an expert on pea flowers and was responsible for identification of one new species and the provision of seeds for the National Arboretum, Canberra .

Jenny joined the Southern Highlands Group at its inception and is a past president. Her interest in native plants and gardens precedes her move to that area. Jenny's wide ranging activities have included working with garden clubs, opening her garden to visitors, plant identification with her collection now housed at Wollongong University, Landcare and bush regeneration, especially on Mt Gibraltar and establishing the Southern Highlands Botanic Garden.

In addition, the Conservation Award was presented to Jane Lemann OAM of the Southern Highlands Group. More than 35 years ago Jane initiated a bushcare group to save and regenerate the highly significant Mt Gibraltar area near Bowral. The resultant group is still active and meets weekly to undertake weeding and regeneration activities. Jane's initiatives also led to the local council establishing a committee related to the environment and conservation and to the introduction of an environment levy to fund local projects. She is now working to add a surrounding area to the reserve. Council officers and other groups value her knowledge and seek her assistance.

# 2023 Outcomes

During 2023, most of our efforts at the state level were focused on membership and conservation. We are also increasing our attention on health and safety. As a fully volunteer organisation, we are not covered by WHS legislation. We do, however, have a duty of care for members and visitors, and as such, we need a robust WH system that was implemented by Heather Miles during her time as president of APS New South Wales.

#### Membership report - Merle Thompson OAM

Both the growth of membership and the provision of member services are primary areas of focus for the Board. In relation to administrative issues, every attempt is made to provide member-friendly services and to facilitate co-operation with District Groups and their membership officers and treasurers.

This year has been a particularly sad one for the loss of life members. Four life members died during the year and we learnt of the death of one other. Edna Devlin, Ron Davies, Jenifer Lewis and Audrey Taggart died during 2023 and tributes to them were included in the eNewsletters. We were also advised of the death of Kath Wray during 2022.

In addition, we were deeply saddened at the death of Margaret Olde, wife of life member, Peter. Margaret was well known for her activities with Menai group as well as her work with Peter in the Grevillea Study Group and on their gardens in the Menai area and at The Oaks.

As can be seen in the tables below, membership at the end of 2023 was slightly higher than at the end of 2022. Membership has been growing over a five year period except for a dip in 2022 but from 2020 it has been a relatively low rate of growth.

The number of new members was higher than in 2022 but lower than in 2020 and 2021. Retention of new members is an ongoing problem. The rate of renewal is rather disappointing.

There has also been loss among longer standing members, some because of age or illness but others just say, for example, unfortunately I cannot renew this year.

#### Treasurer's report – Harry Loots

I am pleased to present the Treasurer's Report for APS NSW for the 2023 financial year based on the Accounting for Good Financial Statement attached. According to figures that the APS NSW accountants have supplied APS NSW made a net profit of \$ 24,238 in 2023. The APS NSW Office, which includes the APS NSW administration and Bequest Fund, made a net profit of \$13,449.

As a result of a pleasing net profit after expenditure items the APS NSW Office equity increased from \$794,023 to \$809,013 in 2023. This places APS NSW Office in a very secure financial position. The APS NSW Board has decided that the Bequest Funds should be used and will be used in future for the employment of a web master to maintain the APS NSW web site.

#### Conservation report - Dan Clarke Conservation Officer

Some of the issues and activities covered on the Conservation front for APS NSW included the following:

- Submission and letter sent to all members of the Hills Shire Council regarding proposed re-development of Fred Caterson Reserve. Modifications to existing sports fields here will impact on remnant trees as well as local bushland.
- Submission to NSW National Parks and Wildlife Services on amendments to feral horse management in Kosciuszko National Park. APS remains deeply concerned about the impacts of feral animals in this and other parks
- Submission sent to Shoalhaven City Council regarding changes to tree protection laws which would enable an increased removal of trees on private property under self-assessment rules. APS remains focused on protecting remnant native trees in urban environments.

In addition, APS Sutherland members, John Aitken, Dan Clarke and Rhonda Daniels, along with Eddy Wajon, conservation office for ANPSA, arranged and attended a meeting with NSW The promotion of APS events and the maintenance of a plant data base take up most of the web master's time. This expenditure fulfils the Bequest Fund's purpose which is the promotion of Australian Plants and the society. This extra impost can be maintained well into the future without affecting the financial well-being of the society.

When speaking to District Group treasurers I am reminded that many treasurers do not realise that APS NSW pays GST on their plant sales and other income. This explains the difference between the figures that groups submit to Accounting for Good and the figures that appear in the APS NSW financial statement.

Department of Planning regarding concerns about impacts to native biodiversity from proposed large-scale solar-power projects. We are encouraging of the installation of renewable energy facilities but not at the cost of vegetation removal.

A project of note and which deserves is the highly-controversial coverage. Lizard Rock development at Belrose. This project is a complicated one for APS as it is a proposal by a Local Aboriginal Council, in conjunction with the NSW Department of Planning, to develop a completely intact area of high-quality sandstone bushland for residential Officer Conservation purposes. Dan engaged Clarke. was to search extensively for any threatened flora on the land over several years and multiple sessions. Dan has decided to no longer work on this project.

Submissions for the project were open in November 2023. There will likely be another round in 2024. APS is strongly opposed to this project which will involve the clearing of completely-intact sandstone vegetation in the inner Sydneyarea and is monitoring the next stage.

#### Report on the Annual Conference of the Nature Conservation Council of NSW– Margery Street

This year's Annual Conference was held in person and by zoom, via which I attended. The NCC is the state's umbrella conservation group, representing more than 180 environmental groups. Despite the State having a sorry record of conservation in NSW the NCC continues to fight for expansion of the national parks system, preservation of our unique native plants and animals, protection of landscapes and wilderness areas. improved bushfire management, better control of pollution and deforestation, and protection of air and water.

Australian Plants Society NSW sent three people; at least five attendees were APS members. One delegate suggested that APS approach the new Secretary and an Executive member, both APS people, to see whether they could "promote APS aims and objectives at the NCC".

The new Chair of NCC is Carolyn Loton, succeeding Don White who chaired for many years and remains on the Executive. Jacqui Mumford was formally appointed CEO. The new Secretary is Susheela Peres da Costa. Eighteen new member groups were admitted, each of which has a compelling environmental issue. For example, The Natural Turf Alliance is concerned about artificial plastic grass being increasingly installed on playing fields.

Pennv Sharpe MLC, Minister f∩r Environment, Heritage, Energy, and Climate Change said that NSW stopped logging in 106 'hubs' on the mid-north coast and promised \$80m for the Great Koala National Park. The Minister acknowledged all 58 recommendations of Ken Henry's August review of the Biodiversity Conservation Act 2016 which can be found here:

As of 1 January 2024, the Department of Planning and Environment was split into two departments: Climate Change, Energy, the Environment and Water; and Planning, Housing and Infrastructure. The Minister also referred to the Restoring Our Rivers Act 2023 which aims to repeal the statutory 1,500 GL cap on Commonwealth water purchases, reduce reliance on buybacks and deliver 605 GLs to communities and the environment.

Jacqui Mumford spoke of public money still going to logging, NCC's fight for the "Yes" vote, relaunching the Environment Awards (you can attend or watch via zoom on Wednesday 27 March 2024 at 5:30pm) and the fact that offsets should be a last resort for developers, rather than standard practice.

There were nine Motions put to the Conference by member groups, two of which were concerned with native forest and urban tree protection. Unfortunately there were no motions from the Natural Turf Alliance nor against persecution of protesters.

The afternoon was as engaging as ever. A panel discussion on ending native forest logging; a workshop "landing wins for rivers and wetlands"; a Plenary panel discussion on winning for climate: coal and gas; and a wrap-up before attendees had refreshments.

It is good to see two fellow APS NSW members, Tony Maxwell and Harry Loots, attending the conference. In future, APS could submit one or more motions, including persuasive background notes, with a chosen champion to speak to them.

#### Directors' benefit and insurance

# Notes to the Financial Statements

#### AUSTRALIAN PLANTS SOCIETY NSW LTD For the year ended 31 December 2023

The financial statements cover the business of Australian Plants Society NSW Ltd and have been prepared to meet the needs of stakeholders.

Comparatives are consistent with prior years unless otherwise stated.

#### 1. Basis of Preparation

The Company is non-reporting since there are unlikely to be any users who would rely on the general purpose financial statements.

The special purpose financial statements have been prepared in accordance with the significant accounting policies described below and do not comply with any Australian Accounting Standards unless otherwise stated.

The financial statements have been prepared on a cash basis starting from 2018 versus an accrual basis prior to 2018.

Significant accounting policies adopted in the preparation of these financial statements are presented below.

#### 2. Summary of Significant Accounting Policies

#### **Cash and Cash Equivalents**

Cash and cash equivalents comprise cash on hand, demand deposits and short term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

#### **Revenue and Other Income**

Revenue is recognised when the business receives it. All revenue is stated net of the amount of goods and services tax (GST).

Interest Revenue

Interest is recognised using the effective interest method.

Other Income

Other income is recognised on a cash basis when the Company receives it.

#### Membership rebates between State Office and Districts

The treatment of rebates of the consolidated Income Statement has changed in 2018 versus 2017 and previous years, where it was treated as income and expenses. It is now accounted for as inter-entity transfers. This change has no impact on the company's overall surplus/(deficit).

#### Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

The net amount of GST recoverable from, or payable to, the ATO is included as part of receivables or payables in the balance sheet.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing

and financing activities which are recoverable from, or payable to, the ATO is classified as operating cash flows.
